#### **Civil Procedure Rules - Amendments & Corrections**

#### (a) Amendments

The Judges of the Supreme Court approved on Oct. 28, 2016, an amendment to Practice Memorandum Number 4 – Courtroom Attire. The amendment may be viewed on the Court's website at:

http://courts.ns.ca/Civil Procedure Rules/cpr 2008 originals and amendments.htm#PMa mends.

The amendment adds the following paragraph to the Practice Memorandum:

#### Personal Circumstances

Lawyers with personal circumstances, such as pregnancy, that require them to wear altered robes or business attire are requested to advise the court clerk, or other court officer, privately or publicly, in advance of the hearing or trial, generally of the circumstances that prevent the lawyer from complying with the foregoing provisions of this practice memorandum.

# (b) Corrections

A couple of corrections were recently made to the Rules, which have now been incorporated in the official consolidated version of the Rules. These are:

### (1) Rule 49

• A correction has been made to the consolidated rules (Rule 49) to include four sittings for Kentville in the chart on page 253.

### (2) Practice Memorandum No. 1 – Foreclosures

• In para 2.5(g) the last sentence in the first paragraph has been updated so that it now reads:

The order shall provide the sale is to be held at a courthouse in the county in which the lands being foreclosed are located, unless the court orders otherwise

 $\circ~$  In the Order for Foreclosure, Sale and Possession a similar sentence has been added to paragraph 3 ~

# (c) Annotated Version of Rules

For those who consult the LexisNexis annotated version of the Civil Procedure Rules, it does not appear that the amendments are up to date (for example, some amendments made by the Court in February 2016 have been omitted or only partially included in the subsequent releases).

# Free Legal Clinic at the Law Courts

The Law Courts in Halifax continues to be home to the Free Legal Clinic. The Clinic is located on the 2<sup>nd</sup> floor of the Law Courts, and is held every Thursday from 9 am to 1 pm in two simultaneous 1 hour sessions held by volunteer lawyers.

The Clinic is intended for self-represented litigants with limited to little experience in the court system. The Clinic provides service for civil matters at the Supreme Court (General Division) and at Court of Appeal, including family law appeals but excluding child protection appeals. It will not provide service on any criminal matters in either court.

Assistant for family law appeals at the Court of Appeal will be provided approximately one Thursday per month.

If you have any litigants in mind that you believe might benefit from this service, kindly refer them to the Court Administration office at the Law Courts.
