Motion

Ken Taylor and Judy Rowter, the Plaintiffs in this proceeding, move for:

an Order certifying this proceeding as a Class Proceeding pursuant to s. 4(3) and 7 of the *Class Proceedings Act*, S.N.S. 2007, c. 28 and appointing the Plaintiffs as Representative Plaintiffs for the Class;

- 2) an Order defining the Class as:
- a) All persons who were implanted with the Wright Profemur Hip Implant System.
- 3) an Order that the within action be certified on the basis of the following common issues:
 - a) Was the Wright Profemur Hip Implant System defective or unfit for its intended use?
 - b) Did any of the Defendants breach a duty of care owed to any of the Class Members and, if so, when and how?
 - c) Does the Defendants' conduct warrant an award for punitive damages and, if so, to whom should they be paid and in what amount?
 - d) With respect to Nova Scotia residents, did any of the Defendants breach a statutory duty under the *Consumer Protection Act*, R.S., c. 92, s.1?
- 4) an Order that the Notice of Certification to the Class Members be given pursuant to the Litigation Plan attached and marked as Schedule "B" to the Certification Order;
- 5) an Order that the Defendants shall be responsible for all costs associated with the Notice of Certification;
- 6) an Order that the Class Members who elect to opt-out of the class proceeding must do so in a manner and within a period of time to be fixed by the Court;
- 7) an Order for costs of this application on a full indemnity basis, including taxes; and
- 8) Such further and other relief as the Court may seem just.
